Donald Dvoracek made a motion to allow Molly to approve the land divisions without prior board approval. Ashley Visner seconded. Motion carried.

**Commissioner's Report:** Kristine Raymond was in attendance. She handed out local informational flyers.

6. Michael Visner presented his Eagle Scout project, which included putting up a sign at Pinora #1 cemetery and cleaning some headstones. Michael gave a cost list of supplies; his preliminary cost was \$420.34. Donald Dvoracek made a motion to accept his costs. Sidney Woods seconded. Motion carried.
7. Renew Lincoln Fire Contract from July 2025 to June 2027. Robert Visner made a motion to accept this contract. Donald Dvoracek seconded. Motion carried.
