Call to Order: The meeting was called to order by Supervisor, Victoria Dennett at 7:00pm.

Pledge to the American Flag: Pledge was led by Sidney Woods.

Roll Call: A roll call was taken. All board members present.

Approve Agenda: Robert Visner made a motion to approve the agenda. Donald Dvoracek seconded. Motion carried.

Clerk's Report: Ashley Visner presented meeting minutes from March 2, 2026. Donald Dvoracek made a motion to approve the minutes. Robert Visner seconded. Motion carried. In addition, Ashley gave the end of fiscal year budget report. For 2025-2026, the township's final income was \$142,784.57 and the final expenditures were \$127,902.82. Treasurer's Report: Donald Dvoracek reported a beginning March balance of \$125,570.08 and ending balance of \$136,555.61 with \$15,854.67 in deposits and \$4,869.14 in expenses. Robert Visner made a motion to approve the treasurer's report. Sidney Woods seconded. Motion carried.

Assessor's Report: Molly Whetstone was not in attendance.

Commissioner's Report: Kristine Raymond was not in attendance.

6. Ashley Visner reported that Platz Electric came to the hall, looked at what needed to be done, and submitted an estimate for \$1,230.00. Robert Visner made a motion to approve the estimate up to \$1,500.00. Donald Dvoracek seconded. Motion carried.
